WARRANTY TERMS FOR LIKEWOOD PVC DECKING

ELIGIBILITY:

This warranty is applicable solely to the original residential purchaser ("Purchaser") of Likewood PVC Decking (the "Product") and is non-transferable. For clarification, a residential Purchaser refers to a single-family residential homeowner.

MANUFACTURER'S WARRANTY:

Likewood Building Products Inc. (the "Manufacturer") provides a warranty to the Purchaser for a period of fifty (50) years from the date of the original consumer purchase (the "Warranty Period"). This warranty encompasses the following:

50-YEAR LIMITED WARRANTY – STAIN RESISTANCE:

The Product is warranted to resist permanent staining caused by spilled food and beverage items, such as condiments, salad dressing, grease, tea, wine, coffee, and other related substances. Proper cleaning with soap and water or mild household cleaners within one (1) week of exposure is required. This warranty does not cover staining resulting from abrasive compounds, paints, strong solvents, metallic rust, or non-food and non-beverage substances.

50-YEAR LIMITED WARRANTY – FADE RESISTANCE:

The color of the Product will not fade more than 5 Delta E (CIE) units from light and weathering exposure. While designed to resist fading, no material is entirely fade-proof over extended UV exposure. Exclusions and limitations apply.

Effective Date: This warranty is effective for residential purchases made on or after June 1, 2019.

STANDARD RESIDENTIAL LIFETIME LIMITED WARRANTY:

This warranty supplements the standard residential Lifetime Limited Warranty applicable to Likewood PVC Decking.

EXCLUSIONS FROM WARRANTY COVERAGE:

The warranty does not cover surface damage caused by metal shovels or sharp-edged tools, application of paint or other coatings not recommended by the Manufacturer, and other conditions listed below:

1. Improper installation according to Likewood's guidelines.
2. Structural alterations or damage due to natural disasters.
3. Unusual service or unintended use.
4. Improper storage or handling.
5. Damage during shipment, storage, handling, or installation.
6. Damage due to movement, distortion, collapse, or settling of the ground or supporting structure.
7. Exposure to extreme heat sources.
8. Staining not on the surface of the Product.
9. Damage due to ordinary wear and tear.

CLAIM PROCEDURE:

To make a valid warranty claim, Purchaser must follow specified cleaning procedures within one (1) week of exposure and, if necessary, have the affected area professionally cleaned at their expense. The claim must be submitted within thirty (30) days of professional cleaning, accompanied by proof of purchase, a description, and photographs of the affected area.

PRORATED WARRANTY SCHEDULE:

The Manufacturer will review the claim and, if valid, may replace the affected item or refund a portion of the purchase price. Prorated coverage applies for years eleven (11) through fifty (50) of the Warranty Period.

Effective Date: This warranty is effective for residential purchases made on or after June 1, 2019.
